1. Check if such a product has a Tariff Specification Code (T.S.C) prior to the importation of the goods to avoid any delays at the borders; and
2. Request for a T.S.C(s) in the event that the product has no T.S.C and the request should be submitted through the respective ports of entry with the following data elements:
  - i. Country of Origin
  - ii. Country of Export
  - iii. Brand Name
  - iv. Commercial Description
  - v. Packaging Specification
